7. Indemnification:


The parties shall indemnify each other and hold each other harmless against any and all direct damages arising from any act or omission pertaining to their obligation under this MoUL

8. Modification:

This MoU may be modified, through a written document signed by dulyauthorized representatives of both parties.

9. Termination:

(a) Termination: Either party may terminate this MoU upon 30 (Thirty days) calcidar days' notice in writing to the other party. However, any outstanding projects shall be completed to the satisfaction of the clients unless it is mutually agreed otherwise.

10. Compliance with laws:

strictly comply with all applicable laws, rules, regulations, data protection compliances, and Governmental orders and maintain in full force and effect all licenses, permits, authorization, registration and qualifications from all Governmental departments and agencies to the extent necessary to perform its obligations hereunder.

11. Dispute resolution:

- (a) This MoU shall be governed according to the laws of India, and each Party shall submit to the jurisdiction of the Courts at New Delhi, India.
- (b) Any and all differences and disputes whatsoever arising between the parties shall in the first instance be resolved mutually between the parties and in the event of a non-resolution the matter may be referred to arbitration.
